PA Dem. State Senator Is Proud to Be Gay

HARRISBURG, Pa. — A Pennsylvania state senator on Sept. 23 came out as gay.

"Hundreds of people know I'm gay, I just never made it an official declaration," said state Sen. Jim Ferlo (D-Alleghany County) as WITF, a public radio station in central Pennsylvania, reported. "I never felt I had to wear a billboard on my forehead. But I'm gay. Get over it."

Ferlo came out during a news conference that focused on adding sexual orientation and gender identity and expression to the commonwealth's hate crimes law. It took place nearly two weeks after a gay Philadelphia couple was attacked as they walked home from a local restaurant.

HIV Prevention

Don Rowinsky reports in the Mahoning Stonewall Democrats newsletter (10/2/14) that the Center for Disease Control

... (CDC), through its Act Against AIDS initiative, launched a new national campaign that encourages gay and bisexual men to *Start Talking*. *Stop HIV*. The campaign was created by and for gay and bisexual men. It promotes open communication about a range of HIV prevention strategies for sexual partners. *Start Talking*. *Stop HIV* features gay and bisexual men promoting life-saving conversations between sexual partners about HIV prevention strategies.

The campaign touches many topics that gay and bisexual men in all types of relationships will want to talk about: HIV testing, their HIV status, condom use, and medicines that help prevent and treat HIV (pre-exposure prophylaxis [Prep], post-exposure prophylaxis [Pep], and antiretroviral therapy [ART]).

However, Charles Veneable, formerly of the Youngstown Health District's Regional Advisory Group for HIV Prevention (now defunct), says that he is not aware of any state-sponsored HIV prevention activity in Youngstown now that the advisory group for this region meets in Canton.

What Makes Students Feel Safe?

We are well aware of the plight of LGBT school children. It has generally lessened in the last seven years but is still dire. Consult the data in GLSEN's study "Over Half of LGBT Students Feel Unsafe at School" (http://thinkprogress.org/lgbt/2014/10/22/3583011/glsen-bullying-study-2013/) for details,

but the practical question is what is improving the climate for these kids. The article offers the following specifics:

Though the picture is still troubling, the outlook is not bleak, which is largely in part to increasing resources in schools. The study found that the positive benefits of these resources are easily identified and explain why anti-LGBT harassment is on the decline, however gradually. Here are some of the features of schools where LGBT students felt more safe:

- Gay-Straight Alliances (GSAs): About half of students reported having a GSA at their school, and those who did were less likely to experience verbal harassment, discrimination, or feelings that they were unsafe because of their sexual orientation. They also felt more connected to their school community.
- LGBT-Inclusive Curricula: Only 18.5 percent of LGBT students were taught about LGBT people, history, or events in their schools, while conversely 15 percent had been taught negative content on LGBT topics. Less than half of students could find LGBT-related content in their libraries or even via the Internet access provided at school. Not only did students at schools with an LGBT-inclusive curriculum experience much lower rates of harassment, but they were more likely to be interested in studying science, technology, engineering, math, or social science in college.
- Supportive Teachers: Almost all LGBT students (96 percent) could identify at least one staff member at their school who was supportive of LGBT students, but only 39 percent could identify as many as a dozen. Those who could felt safer at school, had higher GPAs, and were four times as likely to plan on attending college.
- Comprehensive Anti-Bullying Policies: Most respondents (82 percent) said that their school had an anti-bullying policy, but only 10 percent reported that the policy specifically enumerate protections based on both sexual orientation and gender identity/expression. Students at schools with a comprehensive policy were less likely to experience verbal harassment and more likely to hear staff intervene when they did.

All of these anti-bullying resources are on the

rise, but conservatives are still adamantly trying to block them. When they do, they are actually holding back the futures of LGBT youth, at least according to the data. As GLSEN Executive Director Eliza Byard said about the new report, "Progress is being made in our nation's schools, but when more than half of LGBT youth continue to report unsafe or even dangerous school climates, we all have a responsibility to act.

Gay Man Is General Counsel to Air Force

Four days before the third anniversary of the end to "Don't Ask, Don't Tell," the U.S. Senate confirmed an openly gay attorney as the



top lawyer for the Air Force. On Sept. 16, the Senate confirmed Gordon Tanner, whom President Obama nominated in April, by voice vote to the position of general counsel to the Air Force. Tanner is the first-ever presidential appointee confirmed by the Senate who's not only openly gay and married to a same-sex spouse, but also a military veteran. Although he served in the civilian side of the Air Force for more than a decade, he had served on the uniform side of the service as a judge advocate general from 1973 to 1977. Activist Ugandan Official —Zack Ford in Thinkprogress, 12/1/14

Two years ago,
[Parliament Speaker
Rebecca] Kadaga was urging
[Ugandan] lawmakers to
pass what was then referred



to as the "Kill The Gays" bill, which would have allowed the death penalty for those convicted of homosexuality. She said it would make a good "Christmas gift" to its advocates. Such a law eventually passed, though the death penalty had been amended down to a life sentence in jail.

[This month, she] warned Christian ministers in the country that they have much to fear from gay rights activists.

"Be very careful because gays are here to distort our heritage," she told clergy gathered for Golden Jubilee celebrations at St. Stephen's Church in Pajwenda on Sunday. "We have discovered that they adopt our children and confine them in gay communities abroad to train them on gay practices. By the time they come back home, they are already influenced by homosexuality and are used to influence others in the community."

N.J. Ban on "Conversion" Therapy Is Legal - NJ.com (Hackensack, N.J.)/NJ Advance Media

A three-judge panel for a federal appeals court on Thursday ruled that New Jersey's ban on LGBT "conversion" therapy does not violate religious or free-speech protections in the U.S. Constitution. The ban, which was signed into law last year by Gov. Chris Christie, is justified on the grounds that it helps protect the public, the panel said.

No Longer Ex-Gay

Yvette Cantu Schneider was interviewed by Hatewatch, a blog managed by the staff of

the Intelligence Project of the Southern Poverty Law Center. The following is based on an article entitled "Redeemed," by Evelyn Schlatter on October 2, 2014, in SPLC's *Intelligence Report*.

Schneider first came to



believe conversion was possible in the church. "To be told week after week that our lives could be significant was like a drug. But, as with all drugs, there was a price. That price was to leave your individuality at the door and conform to what church leadership expected of you, to do as you were told, all in the name of serving the omniscient, omnipotent God."

She was disciplined by mentors within her religious community but did not undergo conversion therapy as such. When she was later disillusioned about the church to which she belonged and also faced serious emotional turmoil for another reason, she sought counseling outside the church and began to reconstruct her life.

Now she recognizes conversion therapy as "a political tool of the so-called pro-family organizations to deny LGBT rights" by demonstrating that sexual orientation is not an immutable characteristic and hence not protected by the Civil Rights Act of 1964.

"What makes ex-gay therapy so devastating," she maintains, "is that people are taught to believe that there is something wrong with them that needs healing. The message that resounds like a relentless drumbeat is that you aren't good enough, and you need to change. It isn't hard to imagine the effect this has on LGBT people, which is why all the major mental and medical health organizations have deemed sexual orientation change therapy efforts not only ineffective, but damaging."

"I think the ex-gay movement will be dead

within the next 10 years. As churches become more gay-affirming, parents and church leaders won't seek parachurch ministries to "fix" in gay Christians what isn't broken. The fact that the ex-gay movement has been a monumental failure with no real, lasting change in those who have sought to negate same-sex attractions and become heterosexual will become more and more apparent to the average lay Christian. This is especially true in the age of social media, when information spreads like wildfire and can't easily be suppressed. I'm sure there will be pockets of people here and there who will still try to change someone's orientation. But the movement as a relevant entity in the push for LGBT rights will be defunct."

Back Door to Marriage Equality? —Charlie Butts (OneNewsNow.com) 9/17/14

In Arizona, Judge John Sedwick ordered the state to issue a death certificate listing the deceased's status as "married" and his partner as his spouse. The case in Indiana involved a lesbian couple, where Judge Joseph Van Bokkelen said the state will issue a death certificate bearing one woman's name as "spouse" when her partner passes away from the effects of ovarian cancer.

The Conservative Voice

One News Now gleefully reports that "the Sixth Circuit has ruled that if a state doesn't want to recognize a gay marriage performed in another state, it doesn't have to. Maybe, just maybe, we've taken our first step away from the edge of the moral abyss."

However, the prospect is only partially rosy: "Arkansas and Mississippi became the latest two states [November 25] to have their gay marriage bans overturned by federal judges, but . . . both orders are on hold so the states can consider appeals."

Obama on Same-Sex Marriage

President Obama opposed marriage equality until May of 2012. He told me that he now believes the Constitution requires all states to allow same-sex marriage, an argument that his Administration has not yet made before the Supreme Court. "Ultimately, I think the Equal Protection Clause does guarantee same-sex marriage in all fifty states," he said. "But, as you know, courts have always been strategic. There have been times where the stars were aligned and the Court, like a thunderbolt, issues a ruling like Brown v. Board of Education, but that's pretty rare. And, given the direction of society, for the Court to have allowed the process to play out the way it has may make the shift less controversial and more lasting."

On October 18, the Vatican released a statement about the pastoral care of homosexuals. Much can be learned by comparing the language of this document with that in an interim draft that was rejected by a vote of 118 to 62. The most interesting aspect of this document is that it deals exclusively with same-sex unions. This is the hot button for the Vatican, trumping sin and salvation.

Second, notice the blatant incoherence of the effort of the majority to combine loving tolerance with moral condemnation of gay families:

There is no basis whatsoever to assimilate or to draw even remote analogies between same-sex unions and the plan of God for marriage and the family. . . . [On

the other hand,] In their regard every sign of unjust discrimination should be avoided.
... [Furthermore,] it is totally unacceptable for the Pastors of the Church to exert pressure in this matter and for international bodies to make financial aid to poor countries conditional upon the institution of laws that establish the "marriage" between persons of the same sex. [Translation by BuzzFlash and T. A. C.; official translations have not yet been made available online.]

Contrast this with the words of the interim draft that was rejected:

Homosexuals have gifts and qualities to offer to the Christian community: are we capable of welcoming these people, guaranteeing to them a fraternal space in our communities? Often they wish to encounter a Church that offers them a welcoming home. Are our communities capable of providing that, accepting and valuing their sexual orientation, without compromising Catholic doctrine on the family and matrimony?

The question of homosexuality leads to a serious reflection on how to elaborate realistic paths of affective growth and human and evangelical maturity integrating the sexual dimension: it appears therefore as an important educative challenge. The Church furthermore affirms that unions between people of the same sex cannot be considered on the same footing as matrimony between man and woman. Nor is it acceptable that pressure be brought to bear on pastors or that international bodies make financial aid dependent on the introduction of regulations inspired by gender ideology.

Without denying the moral problems connected to homosexual unions it has to be noted that there are cases in which mutual aid to the point of sacrifice constitutes a precious support in the life of the partners. Furthermore, the Church pays special attention to the children who live

with couples of the same sex, emphasizing that the needs and rights of the little ones must always be given priority.

The difference between the two statements is not doctrinal, for both decline to recognize same-sex unions as marriage and declare that financial aid must be blind to the recipients' position on this issue. Rather, the difference is in the majority's rejection of non-doctrinal concessions about the humanity, dignity, and worth of homosexuals and their partnerships. The Vatican majority vainly attempt to masquerade as nondiscriminatory while at the same time insisting that how and where individuals touch each other's bodies can invalidate their spiritual worth and the value of their relationships.

Yet there is hope in two facts: (1) that a third of the highest-ranking Catholics in the world voted for the interim draft's language, and (2) that all of the voters were considering homosexuality not as a matter of mere sexual activity but as a matter of affectional unions, interpersonal connection.

Parents Seek to Reform Church from Within

Rob and Linda Robertson did what they believed was expected of them as good Christians.

When their 12-year-old son Ryan said he was gay, they told him they loved him, but he had to change. He entered "reparative therapy," met regularly with his pastor and immersed himself in Bible study and his church youth group. After six years, nothing changed. A despondent Ryan cut off from his parents and his faith, started taking drugs and in 2009, died of an overdose.

"Now we realize we were so wrongly taught," said Rob Robertson, a firefighter for more than 30 years who lives in Redmond, Wash. "It's a horrible, horrible mistake the church has made."

The tragedy could have easily driven the Robertsons from the church. But instead of breaking with evangelicalism — as many parents

in similar circumstances have done — the couple is taking a different approach, and they're inspiring other Christians with gay children to do the same.

They are staying in the church and, in protesting what they see as the demonization of their sons and daughters, presenting a new challenge to Christian leaders trying to hold off growing acceptance of same-sex relationships.

It's not clear how much of an impact these parents can have. Evangelicals tend to dismiss fellow believers who accept same-sex relationships as no longer Christian. The parents have only recently started finding each other online and through faith-oriented organizations for gays and lesbians such as the Gay Christian Network, The Reformation Project and The Marin Foundation.

I'm sorry that whatever insecurities you have don't allow you to accept others for who they are. I'm sorry that I threaten you.

I'm NOT sorry I'm gay. I'm proud to be this way. I'm proud to be confident enough to love who I love and to love me. I proud to have friends and family that love me regardless of me. Honestly, I'm not sorry.

day, he posted on
Twitter yet again,
this time so he
and his boyfriend
could thank
everyone who has



sent him well-wishes and comforting thoughts.

Simply incredible. The empathy he shows his attacker for the personal demons lurking within him is empathy I don't know if I could muster. Going bravely forward, he shows that his innate dignity was in no way compromised by someone else's violent and ignorant shortcomings. It has been both touching and inspiring to the thousands of people who have picked up his Tweet and shared it since it was first posted last Thursday.

Soldier of Change

In September 2014, Soldier of Change by Stephen Snyder-Hill was released by the University of Nebraska Press. Mr. Snyder-Hill was the soldier who, on September 22, 2100, at the Republican presidential primary debate, asked.....

"The question I asked (uncut) was: Hello, I'm a soldier currently serving in Iraq, and I have a question for the Republican candidates. In 2010, when I was deployed to Iraq, I had to lie about who I was, because I am a gay soldier and I didn't want to lose my job. My question is, under one of your presidencies, do you intend to circumvent the progress that has been made with gay and lesbian soldiers in the military? Also, would you consider extending the same spouse benefits to gay and lesbian soldiers who are legally married as you do to our heterosexual counterparts? 
Murder Most Queer: The Homicidal Homosexual in the American Theater

Membership Report and Dues Request, 2014-15 —Steve Schildcrout, Treasurer

As our annual membership drive nears its end, so far we have 18 paid households joining or renewing for 2014-15. This is the same number as last year's, but six of these are new or reinstated memberships.
